

Step-by-Step Stock and/or Mutual Fund Shares Gift Instructions

The following are step-by-step instructions for making a stock or mutual fund shares gift either to The Catholic Foundation of Southern Nebraska, or to a Catholic institution or organization served by The Catholic Foundation.

1. Complete the attached “Stock and/or Mutual Fund Shares Gift Information Form”
2. Inform The Catholic Foundation of the shares transfer (gift) in one of three ways:
